Hard copies will be available at the Administration Office for members to pick up if wanted and at Elders meetings.


We value your involvement and aim to make this transition as smooth as possible for everyone. Your cooperation in providing your email is greatly appreciated.

HOUSING AND PUBLIC WORKS UPDATES



Attention: All home owners/ renters

Winterizing your Home

- Make sure you disconnect and put away any hoses
- Turn off your outside taps
- Clean gutters
- Examine your exterior walls to make sure no siding is loose and will blow off in the wind.
- Change your furnace filter
- Put away any things that can fly away in the wind or freeze and damage during cold spells especially pools, lawn furniture, gazebo's, trampolines need to be disassembled or secured down so high winds do not blow away and cause injury or damage to others property or person.
- Do a walk around making sure your roof has no loose tiles and no tree branches are going to fall and damage your roof
 - or any other properties. - Make sure you winterize your RV properly or major damage can happen to water pipes, pumps, etc.
 - If your home is drafty you can purchase at a hardware store, clear plastic to apply to your windows with a blow dryer
 - Ensure your pilot lights on your furnace and hot water tank are not blown out by high winds, if you have a pilot light. This can lead to gas leak and no heat or hot water.

Remediations

Sumas First Nation Lands Department has issued several Stop Work Orders over the past few months. Here, you will learn what the Lands Department has been doing and where we plan on going over the next few months and years.

Handlers Equipment

The Environmental & Archeological Monitor works directly with project partners to ensure traditional land use and provide environmental, cultural, and archaeological monitoring services to minimize any impact that specific projects may present. Sitting at the fourth front of this edition is Handlers Equipment. The SFN Environmental & Archeological Monitor completes site inspections of all properties in our community. When Ms. Schwartz inspected Lot 17 and Lot 126, at first glance she noticed several oil stains littering the property along with unsafe storage of batteries, hydrocarbons and equipment leaking hydro carbons.

Site Observations

• Surficial hydrocarbon staining of site soils and asphalt was observed throughout the Handlers Site. Staining was observed in isolation and directly below parked machinery and/or equipment under repair.

At the northern limit of the asphalt, staining was also observed to extend off the asphalt and onto the gravel adjacent to the property line, thus suggesting hydrocarbons could potentially have migrated offsite.

- Several machines and/or equipment under maintenance were being actively drained of fluids (engine oil, hydraulic fluid, fuel) with improper containment measures and, in some cases, over non-paved areas.
- The catch basin in the center of the maintenance area (Photograph 6) drained into an oil water separator prior to flowing into the 'discharge' pit. The soil within the discharge pit was heavily saturated with hydrocarbon fluids with no obvious mitigation or protective measures.
- Several machine parts (excavator arms and gears) were stored directly on exposed gravel, leaching grease into the underlying exposed soils.
- Batteries were improperly stored outside and exposed to the elements.
- Waste oil containers were left open, and no secondary containment was present.

Recommendations from our Qualified Environmental Professionals

Based on the information available to Arcadis IBI Group recommend the following actions:

- Handlers (site operator) work with their Qualified Professional (QP) to assess and delineate identified impacts to soil at the location. And, assess and delineate potential impacts to all other areas of the Site and in all affected environmental media.
- After sufficiently identifying, assessing, and delineating impacted media, a Remedial Action Plan (RAP) should be developed and enacted.
- All impacted media should be remediated under the direction of the QP and disposed of at an offsite facility that is permitted to accept contaminated materials.





- Following completion of remedial works, a Confirmation of Remediation report should be produced, indicating; the locations and extents of the remediated areas, contaminants of concern (COCs) remediated, soil remediation volumes, confirmatory sample locations and analyses and any subsequent post remediation monitoring (if required).
- Handlers should retain a QP to develop an Environmental Management Plan (EMP) for the site operations and enact this EMP to prevent future recurrence of events.

<u>Update</u>

This site is nearly finished undergoing remediation. Without Ms. Schwartz's attention to detail, courage, and commitment to not only Sumas First Nation but the environment, she was able to catch all the environmental impacts and work very closely with Sasha Tuttle, Arcadis IBI Group, and Envirochem to ensure all the impacts were remedied. Sumas First Nation Lands Team looks for solutions while encouraging developers to do their part to protect the environment and our ground water. This is not always an easy task as we experienced pushback from a few of those developing in the SFN community but eventually we had breakthrough, and we are working closely with developers to ensure the highest environmental standards are being met.

Fraserway RV 2021 Fire

A total loss fire occurred on the current Fraserway RV site in November 2021 which impacted over 400 recreational vehicles. The SFN Lands Department with support from Arcadis (SFN's Qualified Professional) reviewed the environmental site investigation and remediation performed by Shaver Environmental Geoscience on behalf of the insurance company for Fraserway RV. The investigation included the collection of hundreds of soil and groundwater samples and the remediation and appropriate offsite disposal of over 6,000 metric tonnes of contaminated soil. The Lands Department was successful in driving home that the remediation works needed to be completed to meet appropriate standards for residential land use to

allow for unhindered future uses of the property. This was Jennette's first experience with environmental remediation and this project was very large and had diverse environmental impacts which made it a learning experience she will never forget. A huge thank you to Arcadis for all their continued knowledge share and support!

Valley Carriers

On July 28th, 2023, a minor to moderate fire broke out on a mulch pile at Valley Carrier's Site. A Stop Work Order was issued three days later and would remain in place until Valley Carriers could develop and implement a plan to reduce the risk of fires breaking out on their mulch piles again. As a result, Valley Carriers installed a sprinkler system, reduced the height of their mulch piles, and provided their staff with Basic Fire Suppression and Safety Training.



During this time, it was also discovered that BC Ministry of Environment and

Climate Change had been in contact with Valley Carriers to inform them about their failure to comply with the *Environmental Management Act* by releasing unauthorized waste. The Lands Department realized that Valley Carriers was failing to manage their stormwater, meaning there was a risk of nutrients leaving the site in the form of leachate and potentially impacting groundwater. After working closely with Jennette, April, and staff from IBI Arcadis, a stormwater management plan was developed by a qualified professional (QP) and implemented. Once April and Sasha were able to perform a Site visit, confirming that the stormwater management plan was working as intended, the Stop Work Order was lifted (Nov 6th). Klassen continues to work with the Lands Department as the Site is monitored for other potential environmental risks. In addition, Sasha and Jennette are working with a QP from Arcadis IBI to review the Site's permit, ensuring that when renewed, the Site will be held to the most relevant environmental laws and regulations.

Fraser Valley Steel and Wire

In July 2023, soil contaminated with unacceptable concentrations of arsenic was found on Lot 160, Fraser Valley Steel & Wire's (FVSW) Site. A Stop Work Order was issued to prevent further contamination of the site and remained in place until all contaminated soil left the Site. The Stop Work Order was lifted in August and fill operations continued as usual. *Continued*



In November 2023, it was discovered that the Site had deviated from their intended Stormwater Management Plan, violating their permit. Large pools of standing water were discovered on site by SFN's environmental monitor and staff had resorted to pumping turbid water off site and onto the neighboring property. Haul roads on site were unmaintained and the Site's wheel wash was struggling to keep up with traffic, causing significant track out on North Parallel Road. A Stop Work Order was issued immediately until a new Stormwater Management Plan could be developed and implemented. After a site visit with a QEP and documentation of the completed Stormwater Management Plan, the Stop Work Order was lifted in trust that FVSW would continue to maintain the haul roads and make the necessary upgrades to the Site's wheel wash. Fraser Valley Steel and Wire continues to work with the Lands Department as the site is monitored for other potential environmental risks.

Timbro

A Stop Work Order was issued to Timbro in early 2023 as soil contaminated with arsenic and benzene was brought onto the Site. Qualified Environmental Professionals were retained to determine the location and extent of the contamination. SFN's Environmental Monitor was brought on site to witness remediation as the contaminated soil was removed from the site. The Stop Work Order was lifted once remediation was complete. Timbro has since been operational and filling the site in preparation for the Sumas First Nation Multi Plex. We are excited to watch the site approach fill completion; the next phase will be to build.

A few things to note...

It has been a challenging year for the Lands Department as Jennette had to complete a departmental restructuring while fulfilling the work as the environmental compliance officer (vacant position for one year). Once the restructuring was finished, she hired an Environmental and Archeological Monitor, April Schwartz (December 2022) and most recently, an Environmental Compliance Officer, Sasha Tuttle (July 2023). It was a lot to undergo in a short period; it was challenging to complete the responsibilities of two positions, facing Stop Work Orders and working with developers and getting FVSW operational while at the same time completing all pressing daily tasks and responsibilities. Still, it was done, and we are moving at immense speed together as a team! *More on this on page 6*.

What we currently see in the community are fill sites. Here, we are bringing the land out of the floodplain. Once the land is brought out of the flood levels, we will be approaching construction, and this is when you will begin to see our community come together. It has been a long road of filling, but there is light at the end of this tunnel.

Throughout the following eight pages, you will continue to learn more about what the Lands Department has been up to. You will also learn about the immense work we have put in this year. Below you will see a few photos taken a Matcon site visit:







Jennette and April completed a Matcon site visit on a very cold and windy day. April continues to monitor each site in the community. The Semá:th Lands Advisory Committee & Tree Law

Over the past two years, the Lands Advisory Committee has been working on the Semá:th Tree Law. The Semá:th Tree Law sets out rules and guidelines for the Lands Department staff to follow which include but are not limited to:

- General Application, Exemptions and Prohibitions
- Heritage Trees
- Tree Cutting Permits
- Replacement Trees
- Tree Protection
- Regulations

Law creation requires a lot of research, several meeting reviews and finally the approval process. The Tree Law has gone through its last LAC reading on November 7, 2023. Sasha Tuttle, the SFN

Environmental Compliance Officer will complete the recommended revisions and it will then go to the Chief and Council for consideration of approving the Tree Law to move on to the ratification process.

The LAC and Lands Department look forward to rolling out this guidance tool in the new year; watch for the notice of ratification and your copy of the Tree Law as it must be ratified by the members of Semá:th and Approved by the Chief and Council prior to taking effect. The MOTI Marshall Lonzo Creek

The Ministry of Transportation and Infrastructure (MOTI) has approached Sumas First Nation to do work on the Marshall Lonzo Creek Project. This project is to divert a western portion of Marshall Lonzo Creek to make way for an off ramp for the Highway 1 widening project at Sumas Way. Jennette sits at the table alongside Councillor Troy Ganzeveld, Brian Jones, Natasha Youngchief and the fellow GNR Team. Sumas was granted a direct award to the project; the SXDL team will work with Sumas Partners to carry the project through. When we got to the site just off Sumas Way in Abbotsford our neighboring First Nations where there: Kwantlen First Nation and Matsqui First Nation, this is reflected in the photo to the left.

Lands Department Restructure & Environmental Investigation of Reserve Lands

The Lands Manager completed a departmental restructuring in November 2022. Here she reviewed the projects, tasks, upcoming developments, and resources. When Jennette took on the Lands Manager position in May 2022 only one employee remained: The Lands Officer, Chantal Douglas. Together they had analized the department and worked on several projects while working parallel on the restructuring of the department. After outlining what the immediate needs were for the department, presenting to Human Resources and the General Manger for approval, Jennette had to fill the positions: Environmental and Archeological Monitor and the Environmental Compliance Officer. Jennette created a well-rounded, well-educated team and they have taken off sprinting, completing an investigation of the entire community; of where we sit environmentally with each development located on the Sumas reserve lands & the border of Westlake Pipe Factory. They also investigated the water ways in our community: Lonzo Creek and Marshall Creek. They had found several contaminated sites, set out Stop Work Orders for the remediation of each site and observed remediation efforts directly. Sumas First Nation is nearing an environmentally clean slate; there is still work and monitoring to be done and you will read more about this in Sasha Tuttle's, and April Schwartz's section of the Annual Report.

Jennette and Sasha will be reviewing the department structure annually and making recommendations for change as the reserve lands grow.

Additions to Reserve

Sumas First Nation has purchased two parcels of land: 80 acres located just off Atkinson Road, and 50 acres located just off Fooks Rd here in Abbotsford. Lands, GNR and Brian Jones have been working with Lands Advisory Board Resource Center on the ATR process. With this we hope the SFN ATR will be included in the ATR Pilot Project. If we are included in the project our ATR process will not be as tedious a process. We will not have to get the City of

Abbotsford's permission for the ATR's, nor will we have to explain what we are going to do on the land after it is added to reserve lands. It will not be the long-drawn-out process where we must explain the infrastructure statures. There is a lot of work to be done on the ATR but the pilot project gives us hope that it will not take 7 - 20 years for the ATR's to be finalized.

SXDL Development and New Business Committee

On November 16, 2023, the Lands Manager joined the SXDL Development and New Business Committee. This is a very exciting committee as here we will complete a Master Plan of the southside lands which includes an interchange, and infrastructure such as sewer, water, etc. Community engagement will begin once we establish tread and progress. This is an exciting opportunity as this is a very diverse, and experienced team.

Land Use Plan (LUP)

In January 2022, Jennette received approval for the funding that she, Brian Jones and Jenna Noppen applied for to update the LUP. Since Lands received approval to update the LUP, Jennette and Chantal have worked diligently with Dillion Consulting, the Lands Advisory Committee, and the members of Sumas First Nation on the Land Use

Plan. The LUP has given Jennette the opportunity to look at different ways to involve the members. Throughout the process the following engagements took place:

The Chief and Council have yet to review the LUP. Membership of Sumas will receive a copy of the final LUP after the Chief and Council complete their review and give permission to the Lands Department to go through the ratification process. In the meantime, Jennette has attached a copy of the Background Report.



Sumas First Nation Development Cost Charge (DCC)

Sumas First Nation is working on a Sumas First Nation Development Cost Charge Law to begin recovering costs of infrastructure required to support growth of the community. The General Manager, Public Works & Infrastructure Manager and Lands Manager are responsible for creating the DCC with Urban Systems; they hope to have this completed and implemented in the next fiscal year.

Legacy Funding

Jenna Nopen, Brian Jones, and Jennette Pierre applied for the Legacy Funding initiative from LAB and the application for the funding was successful! The purpose of this initiative is to provide funding and assistance to Operational First Nations to identify, review and resolve

outstanding land or environmental legacy issues that arose from the management era of Indian Act administration and that are causing the First Nation to experience difficulties implementing their Land Code and related laws within the boundaries of their Reserve lands.

The LABRC selected Sumas First Nation and granted SFN up to \$300,000, upon completion of milestone deliverables and receipts, for eligible project costs. Sumas First Nation will only be reimbursed for costs and expenses incurred up to the approved project funding amount. Sumas has up to two years to complete the project. The Job Posting for this position went out *November 9, 2023*, more information to come once we hire the successful candidate!

Habitat Restoration - Marshall Lonzo Creek

Jennette and Sasha teamed up with Sumas Park Estates and Fraser Valley Steel and Wire on a Habitat Restoration Project for the Marshall Lonzo Creek. The project will cost approximately \$2 million, and the developers agreed to pay ensuring to restore the creek, create an hour-long pathway along the north and south side of Marshall Lonzo creek on the western side of Sumas Mountain Road. The project includes:

- Native plants, trees, and berries
- A paved pathway
- Solar lighting
- Information Boards
- Barn Swallow Structures
- Chain Link Fence etc.

The plant species chosen for this project were based on research performed by Sasha Tuttle on plants that are both native to the region and hold cultural significance to Sumas First Nation. Sasha reviewed literature on culturally important plants and spoke with Elders at an Elder's lunch for their insight on the draft list of species.

The objective of this project is to restore the natural groundcover and sub-canopy species with native trees species to achieve a high density. Invasive plants that dominate the area will be eradicated and plant diversity will be significantly increased; a strategy that aims to support greater wildlife diversity and provide a net improvement for fish habitat. In addition to this, the enhanced riparian area will act as a buffer to mitigate potential adverse effects that may occur from stormwater runoff or other impacts from adjacent developments.

A vegetation survival rate of 100% during any year of the monitoring program is to be achieved. Should survival fall below 100% during any year of the monitoring program, the Proponent shall ensure the immediate replacement of plantings. Plantings within the SPEA will be monitored for a period of 5 years. A Qualified Environmental Practitioner (QEP) will be responsible for the 5-year monitoring of the SPEA plantings and provide SFN with written confirmation upon completion of the plantings so the first-year monitoring can commence. Monitoring is to include annual inspection reports.

This is going to be a place where you can enjoy family time while getting exercise. Jennette began talking to developers in November of 2022. She referenced the Sto:lo Resources Archeology study and began bringing the project to life with Sasha as each month progressed. Once the plans are finalized, the report will be shared with the membership of Sumas. This is a very exciting project that Jennette and Sasha are extremely proud to be a part of!

Japanese Knotweed Treatment & Monitoring

Japanese knotweed, a very destructive invasive plant species, continues to be observed on the Reserve with patches being recorded near the Marshall Lonzo Creek, several of member's private properties and on a few industrial Sites. Sasha and April continue to document and organize the treatment of knotweed on reserve. Lands is urging members with knotweed on their property or members who would like to report a patch of knotweed to contact the Lands Department right away. The Lands Department continues to urge members NOT to cut or trim knotweed found on their property as the plant can spread through fallen leaves and fragments, thereby requiring professional treatment to prevent further spread.





Wills and Estates

This year Sumas received \$50,000 from ISC to help members create a will or update their existing will. Chantal searched for lawyers that had knowledge on how to do Wills for people living on-reserve, you would be surprised how difficult it was to find a

company on-reserve will writing experience. Woodward & Company was recommended as they are familiar with onreserve laws, working with Land Code etc. Sumas has worked with Murray Browne (a lawyer at Woodward) since the creation of Land Code. Chantal and one of the lawyers had worked together to set up meetings with members, they started off with elders, then moved to those who hold allotment/Certificate of Possessions (C.P.). There were available time slots so they opened up the Wills & Estates writing workshop up to all members. The lawyers from Woodward came to SFN at the end of May, they met with members for two days updating and/or creating wills. There were 17 wills created in those two days; they are still working on finalizing the first drafts. Once they are done, they will contact the members to set up meetings to go over and sign their wills. Chantal will be working with them to set up a date and have them schedule time for other members to complete their wills. With our budget we can complete up to 15 more wills. Chantal will send out another announcement for round 2 of will writing once a date with Woodward is finalized.

Conferences attended with LABRC

Throughout the year there have been several meetings and conferences held by the Lands Advisory Board Resource Centre (LABRC). Chantal attended the Links to Learning Conference in December 2022 at the Westin Bayshore in Vancouver. At this conference she attended several workshops on various topics; here she was able to connect with people from LABRC and other Indigenous communities. LABRC hosts regional meetings every 3 months, this year they were held in Leq'amel, S.A.Y and Cheam First Nation. At these meetings we connect with other Nations from across BC. Here Nations showcase special projects they have been working on and LABRC presents topics that Nations asked to learn more about. The Lands Advisory Board held their AGM at S.A.Y. on September 26 & 27 this was a two-day event that Jennette & Chantal were able to attend.

In June of this year Chantal traveled to Quebec with Councillor Troy Ganzeveld for The Enforcement Conference. It was information packed conference where they were able to learn how other Indigenous communities enforce their laws and policies. The presenters consisted of those who operate under land code, and communities that are not yet operational. They were there for four days and learnt a lot from the presenters, Keynote speakers and LABRC. Occasionally LABRC will have training opportunities for employees to help improve their knowledge of various skills and tools. Chantal went to one of the workshops in Victora to expand her knowledge about the First Nations Land Registry (FNLRS). She was there for three days and learnt various ways of registering and searching for documents. LABRC has many opportunities and ways to connect with other Nations, they are always willing to help with any questions we have, and we are grateful for their generous knowledge share.

Invoicing

Throughout the year Sumas has various sites bringing in fill to raise the land out of the flood plain. This year Lots 25, 82, and 160 are bringing in fill under their fill permit; these lots keep count of how many trucks come in each day and what kind of load they are carrying. By the 5th of the following month, they will email their counts and the

destination the trucks came from to Chantal, and she will draw up an invoice and ensure they are paid by the developers.

Chantal also invoices developers for the soil testing and remediations that take place on their sites.



Business Permits

Each year Chantal reaches out to all the businesses that are located on Sumas First Nation to have them either renew or apply for a business permit; these Permits will be effective from January 1st to December 31st. The reminders for renewal go out at the end of November and mid-December with an application for them to complete if it is a renewal an invoice is also sent at that time. There are currently 31 businesses residing on Sumas Lands, and 2 of them are run by members of our community. Out of the 31 businesses 17 of them are in Kilgard Business Park while the rest are all throughout the community.

First Nation Lands Registry

For the past two years Chantal has overseen the First Nation Lands Registry for our community. In May of this year, she Transferred 8 lots from one member to another as per the Landowners request. She recently registered a Modification of Mortgage for Sumas Park Estates which included 30 different



lots and registrations. She also registers all leases, sub-leases, Allotments, BCRs, and permits. Chantal will pull Parcel Abstract Reports or any documents that have been registered in the First Nation Lands Registry so we can ensure we are abiding by all historical and present legal documents.

CP's/ Allotments

Chantal noticed that a few of files had missing documents or had documents with multiple errors in the files that we inherited from previous employees. All errors and/or missing documents have been sorted through with a fine-tooth comb. Lands met with Chief and Council, informed them of the historical errors; here the Council signed documents that were revised and/or reissued.

She began registering allotments for those who have all the documents pertaining to their files. If your file is in complete or has an error she will set up a meeting with you so you can sign the documents that affect your allotment. Rest assured we are getting to the bottom of all the historical issues. It has been taking some time, but we are nearing completion.

Development Applications

Jennette has received multiple development applications this year. She has worked closely with five new developers, getting them through the development processes. Since the beginning of this fiscal year, three developers left the table, all for different reasons.

FVSW has stood the test of time; they are Jennette's first development that has gone through the beginning phases of the development processes, the tedious fill application process, and the subleasing processes; they are now filling the site. These are time-consuming, but Sumas has excellent procedures and laws that guide us through each step; we have created great relationships as we continue pressing through each step one by one. They continue being monitored by both April and Sasha and have run into a few hiccups along the way. It has been an immense year of learning for all of us involved; with learning comes success.

Land Surveying Capacity Development Program


